### Fees Conditions:

- The cost of course tuition is met by tuition fees and government funding (if applicable). Please note: Students studying a Personal Interest course are not eligible for government study assistance
- As required, fees paid are held in a Trust Fund
- No student shall graduate unless all fees and other costs have been paid in full
- Course fees do not include textbooks and course related materials or equipment. Full-time students should allow approximately \$1200 per year for books and other course related expenses
- Students who change their mode of learning from on-line to on-campus, or vice versa (after 10 working days from the beginning of the semester), will be charged a \$50.00 administration fee per course (includes GST for students based in NZ)

### Student Loans & Allowances – for eligible Domestic Students only

SPCNM's programmes are NZQA approved therefore students, who meet Studylink criteria, are eligible for Student Loans through Studylink. Note: students who study full-time may be eligible for student allowances and course related costs. Part-time students may only apply for course fees. ### Fees-free Study – for eligible Domestic Students only

If you are planning to start tertiary study for the first time you may be eligible for Fees-free. SPCNM encourages all applicants to visit the Tertiary Education Commission (TEC) Fees-free website, [www.feesfree.govt.nz](http://www.feesfree.govt.nz) to check whether you are eligible or not. If you have studied overseas, we advise you to contact the TEC to discuss your eligibility status.

### Note:

To be eligible for Fees-free, a Student Loan or Student Allowance you must be a New Zealand citizen. If not a New Zealand citizen, you must be an ordinarily resident in New Zealand and meet one of the following residence requirements: have been entitled to reside indefinitely in New Zealand under the Immigration Act 2009 for at least 3 years and have been living in New Zealand for at least 3 years; or be a refugee or protected person and be entitled to reside indefinitely in New Zealand under the Immigration Act 2009; or be sponsored into New Zealand by a family member who holds refugee status or protected person status.
